1. Charges

Full payment, including any deposit, is due at pickup. If the Equipment is not returned by the Date and Time Due Back, Renter will be charged the rental rate for each additional day until it is returned, plus a service charge of 1.5% per month on any unpaid balance. The deposit is applied to any amount owed, with the balance refunded after the Equipment is returned and inspected.

2. Condition, Fuel & Return

Renter has inspected the Equipment and accepts it "AS IS" in good working condition. Equipment must be returned by the due date/time in the same condition (ordinary wear excepted), with fuel refilled and free of chemical residue or debris, or Renter will be charged for fuel, cleaning, and/or repairs.

3. Safe Use

High-pressure washing equipment can cause serious injury if misused. Renter and all operators must be competent in its safe operation, wear proper eye/ear protection and non-slip footwear, and must never: point the Equipment at any person, animal, or unintended surface; leave it running or under pressure unattended; operate it indoors or without ventilation if gas/diesel/propane-powered; use it near electrical lines or equipment; modify it; or operate it while impaired or under age 18. Renter is solely responsible for site safety and compliance with applicable law.

4. Assumption of Risk, Release, Indemnification & Damage

RENTER ASSUMES ALL RISK OF INJURY OR PROPERTY DAMAGE FROM POSSESSING, TRANSPORTING, OR USING THE EQUIPMENT AND, TO THE FULLEST EXTENT PERMITTED BY LAW, RELEASES AND WILL INDEMNIFY HIGH PSI LTD., ITS OWNERS, EMPLOYEES, AND AGENTS FROM ALL CLAIMS, LOSSES, AND LIABILITY (INCLUDING BODILY INJURY, DEATH, AND PROPERTY DAMAGE) ARISING FROM THIS RENTAL, EXCEPT FOR HIGH PSI'S GROSS NEGLIGENCE OR WILLFUL MISCONDUCT. THE EQUIPMENT IS PROVIDED "AS IS" WITH NO WARRANTIES, EXPRESS OR IMPLIED, AND HIGH PSI IS NOT LIABLE FOR INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES.

Regardless of fault, Renter is responsible for all loss of or damage to the Equipment while in Renter's possession, and will pay High PSI's repair cost or, if the Equipment is lost, stolen, or damaged beyond repair, its full replacement cost, less any deposit collected.

5. Default

Failure to return the Equipment or pay any amount when due is a default. High PSI may, without notice, terminate this rental and repossess the Equipment, and Renter is liable for all resulting charges and reasonable collection and attorney's fees. This Agreement is governed by Illinois law.
